ORDINANCE

- 253-2013. That Chapter 44, section 10 of the Code of the City of Fitchburg, under Positions Paid Annually, as most recently amended, be further amended by adding thereto: School Committee Vice Chairperson and School Committee Member effective January 6, 2014:
School Committee Vice Chairperson \$5,000.00 (payable monthly)
School Committee Member \$4,500.00 (payable monthly)

PETITIONS

- 46-2013. Councillor Jody Joseph and Councillor Nicholas Carbone and the Elm Street Neighborhood Association to institute a Property Registration Ordinance.
- 51-2014. Councillor Marcus DiNatale to amend Chapter 3 of the Fitchburg City Code to remove the Dept. of Finance and Administration and in its place the following: have Assessor and Auditor divisions become stand-alone departments reporting directly to the Mayor, and have a Dept. of the Treasury where the divisions of Information Technology and Purchasing report to the Treasurer and the Treasurer will report directly to the Mayor.
- 52-2014. Councillor Marcus DiNatale to amend Chapter 3 of the Fitchburg City Code to remove the Dept. of Human Services and in its place the following: The divisions of Seniors, Veterans, Library and Recreation now be stand-alone departments reporting directly to the Mayor.

- 176-2014. Councillors Marcus DiNatale and Amy Green to amend the Fitchburg City Code, where applicable, as outlined (Performance Evaluations).
- 138-2015. Samuel R. Blair, Chairman – Fitchburg Historical Commission, to have the members of the Fitchburg Historical Commission be designated as Special Municipal employees as outlined.
- 241-2015. Councillor Angelo Bisol to change the current Ordinance to reflect MGL Ch. 90 s. 51E: Create and establish an Airport Commission for the City consisting of five members plus the Mayor, the President of the Council and the Commissioner of Public Works, who shall be ex-officio members.
- 23-2016. Vincent Pusateri, II, City Solicitor to designate the positions of City Solicitor and Assistant City Solicitor as special municipal employee positions under MGL Chapter 268A section 1(n).
- 24-2016. Vincent Pusateri, II, City Solicitor to designate the positions of Airport Commissioners as special municipal employee positions under MGL Chapter 268A section 1(n).
