 - Review & Approve the *Revised DRAFT “Sewer Rules & Regulations”* (update of previous DRAFT “Sewer Rules & Regulations” provided by Arcadis {consulting engineer}), provided to the W/WW Commission at the Sept. 9th, 2020 Commission Meeting.
