PUBLIC COMMENT

There was no public comment.

CALL TO ORDER

The meeting was called to order at 6:33 p.m.

APROVAL OF THE MINUTES

The minutes of the April 10, 2019 were approved.

CHAIR'S REPORT

Chair Walsh said there was no new information regarding the building project.

He reported that he and Director Bernard had attended a meeting of the Fitchburg Redevelopment Authority and after discussion the FRA agreed to turn the parking lot on the northeast corner of Boulder Drive and Newton Place, directly behind the Youth Library, over to the city. There are discussions ongoing with attorneys as to the next steps. It was FRA member Jim Hohman's last meeting and he expressed strong support for the Library obtaining the lot. This will allow more freedom to the architect designing the final plans.

LIBRARIAN'S REPORT

Director Bernard said there was no correspondence to report. She has included a list of future programs in the packet distributed to the Trustees.

Director Bernard said the meeting of the Massachusetts Trustee Institute had been of great interest. The main topics were ways to help trustees understand that advocacy is every trustee's job and to suggest means by which they can become more effective on the national, state and local level. There was also a panel discussing the roles library foundations can play in advocating and advancing the development of libraries.

COMMITTEE REPORTS

Finance Committee- Michael Phaneuf distributed the most recent financial Trust Fund figures from Jim Hohman of First Financial

Legislative Affairs Committee- Director Bernard said everything in the MBLC budget had passed. Policy Committee- Director Bernard said there are policies that need to be written. Those that have been voted need to be collected in one place for ease of use by staff and the public. As policies are needed, they will be written before submitting them for discussion.

NEW BUSINESS

The Trustees voted to approve the submitted FY20 Trust Fund budget. The Director said she was reducing Trust Fund spending because the yearly income continues to be low.

OLD BUSINESS

Chair Walsh said he was setting up a meeting soon to plan for the Library Anniversary Gala. He also sought ideas for some kind of continuing program that would be a yearlong celebration of the Library. He asked any Trustee who had an idea to pass it onto him.

ADJOURNMENT

The meeting adjourned at 7:35 p.m.
